- Weekly email bulletin with important opportunities and dates
- Parents receive all-call messages, texts and personal calls when possible to be invited for school meetings
- Monthly meetings that are regularly scheduled at times that are convenient to families, e.g., morning and evening meetings on the last Thursday of each school month.

We offer two parent meetings each month from August through May. Meetings are the last Thursday of each month. One meeting at 8:45 A.M., the other is at 5:30 P.M.

As a school-wide TItle I school, EPAA engages parents in many ways to engage them in the planning, review and improvement of the school's Title I programs.

Title I programs are focused on supporting our goals for graduation and A-G readiness, as measured by attendance, graduation rates and A-G graduation rates. We will work together to evaluate the strengths and challenges of our college-going team, access to academic supports and programs. We meet monthly, with two times available for parents to meet with school administration, parent support staff and the college and career specialist.

EPAA communicates with parents about their individual students through regularly scheduled parent/teacher conferences as part of the Advisory program, throughout their four years. Additionally parents may request meetings with school counselors and administrators whenever necessary.

- Back to School Night and the annual grade level meetings in which we share the transcripts and discuss college and career planning.

The school engages Title I, Part A parents in meaningful interactions with the school. The Compact supports a partnership among staff, parents, and the community to improve student academic achievement. To help reach these goals, the school has established the following practices:

In addition to the regularly scheduled meetings listed below, we offer workshops for parents on a regular basis, including "Cash for College" and direct support in completing the Financial Aid applications and FAFSA specifically. As part of the monthly SSC meetings parents can learn about the Common Core standards, EPAA curriculum and class offerings, assessment design (e.g., the introduction of more Project Based Learning), and how to monitor and improve the achievement of their children through a variety of supports, including communication through CANVAS, advisory meetings and the school sponsored workshops.

We communicate with parents about their individual students through:

- Student led conferences twice a year

- Back to School Night and the annual grade level meetings in which we share the transcripts and discuss college and career planning.

We regularly communicate with parents interested in leadership using:

The school provides Title I, Part A parents with materials and training to help them work with their children to improve their children's achievement (ESSA Section 1116[e][2]).

As part of the regular monthly meetings we work together to develop plans for student and parent participation, in addition to workshops and exercises around how to engage parents in thoughtful forms of on-going communication, and workshops such as "How to Speak to Your Teen" and SMCOE co-sponsored "Parent Project" workshops.

The school coordinates and integrates the Title I, Part A parental involvement program with other programs, and conducts other activities, such as parent resource centers, to encourage and support parents in more fully participating in the education of their children (ESSA Section 1116[e][4]).
